Community Benefit Implementation Strategy

Introduction

At Children's Hospital Los Angeles our mission is to "*Create Hope and Build Healthier Futures*." As a leading academic children's hospital, we fulfill our mission by caring for children, adolescents, young adults, and families, advancing knowledge, and preparing future health care providers.

In FY19, Children's Hospital Los Angeles (CHLA) conducted a Community Health Needs Assessment (CHNA) in an effort to understand the health care needs and issues that affect children and adolescents in our community. The CHNA incorporated existing demographic and health data for the community served. It also included collection and analysis of input from persons who represent the broad interests of the community served by the hospital, including those with special knowledge of public health. The CHNA complies with California state and federal regulations regarding the provision of Community Benefits.

As part of the CHNA, health and social needs were identified through an examination of primary and secondary data and then prioritized through a structured process using defined criteria.

Included in this process were the hospital's Community Benefit and Community Impact Advisory Committees, community leaders and representatives. The findings of this process were utilized by the hospital's Community Benefit Management to guide the development of the hospital's 2019 - 2021 Community Benefit goals into three broad domains.
